#### NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31st MARCH 2018

## 1. ACCOUNTING POLICIES :

# A. METHOD OF ACCOUNTING

The financial statements have been prepared on the historical cost convention and in accordance with normally accepted accounting principles.

## **B. RECOGNITION OF INCOME & EXPENDITURE:**

Revenue is recognised and expenditure is accounted on their accrual. Restrictive grants are accounted as income on the satisfaction of the conditions attached to the grant.

#### C. TAXATION:

No provision for taxation is made in the accounts in view of exemption available to the Trust u/s 11 of the Income Tax Act 1961.

## 2. EXPENDITURE ON PRINTING BOOKS:

The CRG carries out various studies on Childrens' rights. The result of some of such studies are in the form of a book or a Monograph on the concerned subject.

Depending upon the decision of the Board of CRG, these books are either sold as a priced publication or are distributed free to schools and other educational and cultural institutions.

The expenditure on these activities is charged to income and expenditure account without deducting (i) the income arriving from sale of books and (ii) the balance of stock of such books with the CRG.
